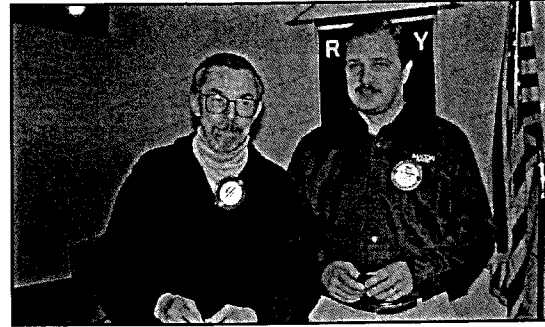

For January: The Economy

Beginning with Highlands Rotary's first meeting on Jan. 6th in 2009, there will be a three part series on the Economy. Tony Potts with Macon County Bank will discuss subprime mortgages: how they came about and what these mortgages represented. On Jan. 13th Brian McClellan with Edward D.
